## 1.Setting: Mandatory therapy for students on counselling course

We often talk about contracts when I'm having supervision for my work with the counselling students (mandatory therapy). I have to write a report on them each year (this is explained to them at the start of therapy), and this forms part of their assessment. The contracts with the course and with the students also refer to my role in assessing their readiness to graduate. This year, for the first time, the course wanted to pass someone that I thought was unsuitable at present. It was a terrible dilemma, and I felt a great responsibility to the public and the profession as well as responsibility to the student.

In my own supervision, I talked endlessly about this dilemma. After a lot of discussion with the course leader, in which I had to be very careful about the confidentiality of the therapy, the student was asked to do an extra piece of work. I did not think that this was at all satisfactory. It has made the therapy very rocky. I have asked for a meeting with the course coordinator to discuss new contractual terms before the next intake.

## 2 Setting Private Practice

I was very sad when a long term client told me that she had a cancer diagnosis. She says she wants me to carry on with her as long as possible. In supervision we thought about what this might entail, and what extra support I might need. My supervisor recommended a book, which I have ordered.

## 1. Setting EAP short contract

I find it very hard to think about one client. He disturbs me in a way that I can't put my finger on, or put into words. I am not frightened of him, but I can't get him out of my head. In supervision I was helped to put all this into words and slowly, together we made some sense of it and I thought that it might be a really powerful communication from him that there was something he couldn't tell me in any other way. This is what it turned out to be. I cannot write the details here. It was a really good example of a countertransference communication, and I couldn't have made sense of it without my supervisor. It took a really long time to work through this with the client and I took him to supervision frequently.
