2.1	Rejection of organisational membership application

	The paper sets out the full history of the current situation, details specific concerns and includes legal advice.		
	In light of the matters identified within section 1 and the legal advice set out in section 2, it is considered that approving the Applicant's application poses a risk to:		
	<ul> <li>the standards for membership of BACP; and / or</li> <li>the standards of the profession; and / or</li> <li>public confidence; and / or</li> <li>protection of the public.</li> </ul>		
	The committee discussed whether the organisation had any other relevant international accreditations. No evidence could be found to respond to this.

It was confirmed that written legal advice has been received on this matter and that colleagues from the Registrar and Professional standards teams have been involved in this discussion previously.

The committee thanked the DPSPR for bringing this to their attention.

### **Decision:**

The committee unanimously agreed to support the recommendation declining the organisational membership application received under section 12.3 of the Articles of Association and approved its submission to the Board.

## 2.2 SCoPEd - progression training course requirements

The Head of Professional Standards spoke to the paper which provides a summary of the development and oversight processes and procedures involved in the development of the new BACP Progression Training Course Accreditation and Approved Qualification schemes due to launch in Spring 2025. Several appendices were also provided.

## The report included:

- a summary of the development and oversight processes and procedures involved in the development of the new, BACP Progression Training Course Accreditation and Approved Qualification schemes.
- an outline of how the progression training schemes will support members in their developmental journey towards Individual accreditation (SCoPEd column B) and Senior accreditation (SCoPEd column C).
- the draft criteria for the new BACP Progression Training Course Accreditation and Approved Qualification schemes due to go to the Board for approval in January 2025.

The committee were asked to scrutinise the robustness of the processes and procedures employed to develop, oversee and scrutinise BACP's new Accredited Progression Training Course and Approved Qualification schemes due to launch between April-June 2025.

The committee asked whether there were any obstacles preventing the paper going to Board in January 2025, it was confirmed that there were not.

Discussions were held around equality issues and it was noted that there has been a study into the impact of SCoPEd.

The process set out in the paper is mindful of the different learning needs of members.

An EDI review is being undertaken on the course accreditation scheme and will be considered in the accreditation training.

The committee commented that it is a very rigorous, clear process and were impressed with the breadth of options provided.

#### **Decision:**

The committee unanimously agreed to recommend to the Board of Governors that BACP's Accredited Progression Training Course and Approved Qualification schemes be approved.

### 2.3 Ethical Framework Review

The Ethics Lead spoke to her paper on the Ethical Framework. The paper gives an outline of progress of the Ethical Framework review and specifically the proposed structure for the updated Framework.

The framework is designed to provide support to members in practice and ensure that they are equipped to cope with issues such as international working and AI.

The paper gives a comprehensive update on 2 areas of the review:

- Current Position on Phase 2 (Consultation and Analysis)
- Current Position on Phase 3 (Create and Publication)

The committee discussed how learning will be mapped and assist the professional conduct team.

It was noted that its is proposed that the new Framework will comprise 3 sections:

- Core responsibilities
- Ethical principles
- Ethics in Relationships

A draft of the revised Ethical Framework is intended to be presented to the Board in June 2025 prior to its release for consolation with the membership.

The paper included a Risk Analysis - identifying 30 risks currently monitored as part of the project. The risks surrounding AI will be analysed by a specialist external consultant. It was

suggested that these should be linked to the corporate risk register and specific risks reported to FRAPP. The incorporation of AI and international work was reassuring to see.		
The committee discussed how new learning on ethics would be best incorporated into training for existing members. An E-learning module is currently being developed.		
BACP will ensure that this is a requirement of all accredited training, and that it is standard practice across all relevant organisations, providing a unified approach with SCoPEd partners.		
It was noted that a legal review noted correlations with other organisations. The supplementary resources and clear distinct voice that BACP offers ensures that we stand out.	у	
The CEO commented that BACP exists for both members and the public, this framework seeks t support both.	.0	
Further updates will be presented to the next PPC committee meeting in February 2025.
